5.3 New Program Proposal - Certificate in Marine Mechanical Technician Foundation

Distributed material: Decision Note

Received and approved as previously circulated. The EdCo Chair highlighted differences between the certificate and the diploma. It was reported that there is a minimum of 175 students to a maximum of 325 depending on incoming cohorts at a time, and approximately 30 staff members at the Marine Campus.

Management answered questions regarding grant funding of \$156k in a steady state and \$702k cumulative over 5 years. It was reported that the program contributes to BCIT's block funding arrangement with AEST. Block funding means that each year BCIT receives a bulk set amount of funding (expressed in the unit of "funded FTE's") against which we need to train and graduate a pre-determined number of students (expressed in the unit of "student FTE's"). Notwithstanding certain sector categories ("buckets"), we are somewhat at liberty to assign these funds to programs of our choosing in order to fulfil the overall training commitment.

This block funding provides the flexibility to leverage highly profitable programs for the benefit of low-profit courses or even loss leaders, if the latter are deemed critically important for the economy or as building blocks for larger credentials and careers.

The opposite of block funding is "targeted funding", where a discrete amount of money is given to specifically develop and deliver a particular credential. The province moved from a 100% targeted funding model to a block funding model (or, more accurately, a hybrid model) approximately 20 years ago.

The CFO confirmed that this program is part of the block funding framework.

The are international affiliate programs that were entered into agreements in prior years with specific other post-secondaries to provide BCIT's curriculum and have these programs delivered at their institutions. In doing so, BCIT was required to name separate programs that differentiated these from domestic programs to be name specific but with the underlying program and to the specific post-secondary institute that was delivering the program. All students have completed the programs and there are no faculty effected by the cancellation, as the underlying programs continue to exist.

IT IS HEREBY RESOLVED, SECONDED AND CARRIED THAT the Board of Governors have been advised by the Education Council that the appropriate process for cancellation of these programs has been followed in accordance with Policy #5405. The Board of Governors approves the cancellation of the:

- 1. Diploma in Mechanical Engineering Technology, Wenzhou Vocational and Technical College, China
- 2. Diploma in Automotive Technical Studies, Osan University, South Korea
- 3. Diplomas in Computer Systems Technology, three affiliated programs:
 - Guangxi Vocational Technology College of Communications, China
 - Sichuan Vocational Technology College of Communications, China
 - Zhong De Vocational Technology Institute, China
