T. Bermudez, VP External, BCIT Student Association provided an overview of the key initiatives undertaken by the BCITSA in the past year. She noted that the BCITSA held a referendum in late March, which passed by a narrow margin (797 for and 793 against). With the passing of this referendum, the BCITSA intends to expand student experience at BCIT through the creation of the Development and Entrepreneurial Centre, renovations of the Pub, additional internal and external advocacy resources, and greater student representation at the satellite campuses. T. Bermudez also provided a brief overview of recent conversations held with Minister Wilkinson and Minister Yamamoto on key issues such as: deferred maintenance and budget allocation, directed studies and applied research, and the synchronicity between BCIT and federal and provincial jobs initiatives.

The Board expressed strong support for integration between BCIT and the BCITSA, and thanked T. Bermudez for her excellent work.
