My name is Shan Satoglu and I am the Program Head for the Healthcare Management Department, BCIT School of Health Sciences.

From 2020 to 2023, I was co-Chair of the SOHS Great Workplace Committee, a committee that was convened by the School to enhance employee engagement through focused initiatives identified by the School.

External to BCIT, I am a Public Representative on the Nurse Practitioner Examination Committee, BC College of Nurses and Midwives (BCCNM) which is a legislated regulatory body in BC. Previously, my local community and my professional service roles have included, Locarno Sailing Society (Board of Directors), BC Chapter of Healthcare Information and Management Systems Society (President).

- I am nearing completion of a 2-year Faculty member term on EdCo and intend to continue into a second term with a focus on accessibility, engagement, and governance.

- Experience in governance and operating perspectives on boards and committees
