

~BC Rehab Gert Vorsteher Memorial Bursary~

The Gert Vorsteher Memorial Bursary for students with disabilities was created by British Columbia Rehabilitation Foundation ("BC Rehab") in 2014 to award two educational grants of \$5,000 each to British Columbians with a physical disability who intend to pursue post-secondary education that will lead to employment and greater personal independence.

This completed application and all required supporting documentation must be received by BC Rehab on or before July 6, 2018 to be eligible for consideration.

Eligibility Criteria

To qualify for the Gert Vorsteher Memorial Bursary, applicants must:

- Be a Canadian citizen or permanent resident
- Have a permanent disability that falls under BC Rehab's mandate
- Be enrolled or accepted for enrolment as a full-time or part-time student at a post-secondary institution in BC
- Demonstrate financial need
