This past year, the Alumni Association has played a key role in marking BCIT's 50th anniversary as we celebrate the achievements BCIT and our alumni have made during the last five decades.

BCIT has been at the forefront of providing career-focused education and training for 50 years, enabling students to graduate with job-ready skills. BCIT has grown from three schools and less than 700 students in 1964 to six schools teaching 47,000 full- and part-time students located on five campuses. In 1979, the Alumni Association was established to support ongoing alumni success. Today, we represent more than 160,000 BCIT graduates working across multiple industries locally and globally.

Anniversary celebrations were launched at a spectacular gala held at the Vancouver Convention Centre on October 6 2014, attended by more than 1,300 people. The Alumni Association was featured throughout the evening and we supported the event by hosting past Association board members, invited alumni, and students.

Over the last year, the Alumni Association Board of Directors has worked with BCIT to enhance our alumni programs to ensure we are providing meaningful opportunities to support graduates in their professional and personal lives.

In the coming year, we will launch two exciting new professional development initiatives for alumni. The Alumni Association Speaker Series will feature keynote speakers from business and industry. The evening events will be held at a signature Vancouver venue, and tickets will be limited to maximize networking opportunities for attendees. In addition, the Association will launch a mentoring program to support young alumni at the beginning of their careers.

The Association also plans to increase the number of member benefits available to alumni. This program is essential because it not only provides discounted benefits for alumni but also generates revenue to fund the Association's programs and supports student success.

Finally, I wish to especially thank our Board and committee volunteers, and also alumni who volunteer at events, for your ongoing commitment to support the Association and BCIT.

BCIT Alumni Association Scholarship and Bursary Endowed Fund

This fund established through the fundraising efforts of the Association and the Foundation and Alumni Relations team provides bursaries, scholarships, and awards to students. The fund grew to \$1,201,416.15 as of March 31, 2015. Since the Alumni Endowment was established, 741 students have received bursaries, scholarships, graduating, and entrance awards valued at \$799,652.
