NOTE: All credentials must have a minimum of 45 credits.

- > have achieved a first class average;
- > have demonstrated active participation in student activities that have brought recognition to the Institute;
- > have demonstrated strong teamwork skills.

☐ The BCIT Board of Governors' Award for Leadership

- > have achieved at least a 70% GPA;
- > have demonstrated outstanding leadership and service to the BCIT community or the community at large.

☐ The BCIT Graduating Achievement Award for Baccalaureate Degrees

- > achieved an excellent academic record;
- > contributed in a positive way to the life of the Institute or the community at large.

☐ The BCIT Advanced Diploma Graduating Achievement Award

- > achieved an excellent academic record;
- > contributed in a positive way to the life of the Institute or the community at large.

☐ **Lieutenant Governor's Medal for Inclusion, Democracy and Reconciliation**

The Lieutenant Governor's medal program recognizes B.C. public post-secondary students in two-year diploma programs and four-year undergraduate programs who have made outstanding contributions to the promotion of inclusion, democracy and/or reconciliation within their campus community.

Eligibility:

Must demonstrate any one of these three award criteria.

Diversity and Inclusion:

This award criterion recognizes students who have promoted diversity and inclusion on campus or in their community. Students must demonstrate strong collaboration and unifying efforts, through the promotion and display of tolerance, and respect for others.

Examples:

- > A student may be recognized for their work in building community through the organization and coordination of events, activities or services, that contribute to a more welcoming and supportive environment on campus,
- > A student may be recognized for their work organizing a community response to an act of intolerance.

Democracy:

This criterion recognizes students who have strengthened democracy through civic engagement or the advancement of human rights. Students must demonstrate recognition of the fundamental rights and dignity of all persons at a local, national or global level.

Examples:

- > A student may be recognized for their contribution to student governance or promoting social change and public discourse on campus, in their community or online.
- > A student may be recognized who has supported, advocated or empowered minority rights and/or the most vulnerable in society such as those with mental health or addiction challenges, the homeless, new immigrant youth or refugees.

Reconciliation:

This criterion recognizes students who have answered this call to Reconciliation and are undertaking important efforts to heal their communities.

Examples:

- > A student may be recognized for their collaboration with a local Indigenous community to start a for-profit business where proceeds support programming for indigenous women.
- > A student may be recognized for teaching indigenous ways of knowing and doing (an indigenous language, law, dance, or another custom) to other students.
