ICES evaluates only formal, for-credit educational programs of study that are at least one year of full-time study in duration. While they may represent valuable learning, professional licenses, apprenticeships, work or life experience, continuing education, courses taken at non-recognized institutions, and non-credit professional development courses all fall outside the scope of what ICES can evaluate.

ICES CANNOT COMPLETE AN ECA FOR PARTIALLY COMPLETED CREDENTIALS.

ICES has been designated by Immigration, Refugees and Citizenship Canada (IRCC) to provide Educational Credential Assessment (ECA) reports for Canadian immigration purposes.

Under the guidelines provided by the Immigration, Refugees and Citizenship Canada (IRCC) ICES will only provide ECA reports for completed academic credentials.

ICES will provide a statement of the general equivalency of international educational credentials to a completed Canadian educational credential.

If you apply as a Physician/Specialist Physician (NOC 3111 or 3112) and intend to pursue licensure you are advised to be assessed by the Medical Council of Canada. Individuals applying as a Pharmacist (NOC 3131) and intending to pursue licensure are advised to have an assessment from the Pharmacy Examining Board of Canada. - An ECA can give you early feedback on how your credentials compare to those in Canada. This report may also be a benefit when you are looking for a job; however, be mindful that being assessed does not guarantee you will get a job in your field or at a certain level. It is recommended that you learn about the job market outlook for your occupation in the specific region where you plan to settle.
- An ECA also does not mean that your work experience and professional credentials are automatically recognized or will be recognized for licensure in Canada. If you work in a regulated profession, you must still go through the process of getting your license in the province or territory that you plan on settling in. Regulatory authorities determine an applicant's readiness for licensure by assessing and recognizing "qualifications" which may include an assessment of education, experience/competencies and language proficiency in addition to other requirements.
- If you plan to work in an occupation that is regulated in Canada, you should contact the regulatory authority in the province where you plan to live as soon as possible. They can give you information about the process for being licensed, including steps you can take before you leave your home country.

- Photocopies of the literal [not interpretive] certified translations of each of these documents into English or French [ICES will forward any official documents requiring translations to you directly should it be necessary]
- Official academic record sent directly to ICES from all educational institutions that you are requesting an assessment for. Please be sure that the documentation you request is issued by the appropriate awarding body/institute/university and not an affiliated college or school.
