

BCIT Facts & Figures Definitions

Full-time Student	Student who is enrolled in a daytime program.
Part-time Student	Student who is enrolled in a part-time or distance education course. Students are counted once in a reporting year regardless of the number of courses registered in.
Enrolment/Enroled	This is an unduplicated student (head) count.
Registrations/Registered/Registrant	This is a duplicated student count. Students can be registered in one or more courses.
International Student	Student who is attending BCIT as an International student and paying international fees. The international counts do not include student's enrolled in BCIT's International Affiliate programs.
Indigenous Student	Student who has self-identified as Indigenous at some point during their education within the B.C. system. The self identification can be during K-12 or at the post-secondary level.
Classification of Instructional Programs (CIP)	Classification of instructional programs (CIPs) is used to code instructional programs or courses by discipline/field of study. <u>Classifications of Instructional Programs, Canada 2011 (Statistics Canada)</u>
Full-time Equivalence (FTE)	FTE represents all full and part-time enrolments converted to the number of students carrying a full-time course load.
Ministry FTE Target	Funding provided by the Ministry of Regional Economic and Skill Development (RESO) that reflects approved training and education to be provided.
Actual FTE	Measures the actual student FTE delivered.
Ministry Delivered FTE	Actual FTEs delivered by BCIT for domestic students that are funded by the Ministry of Regional Economic and Skill Development.
ITA – Apprentice FTE ITA – Foundation FTE	Actual FTEs delivered by BCIT for domestic students that are funded by the Industry Training Authority (ITA) and separated out by Apprenticeship or Foundation program types.

International Delivered FTE	Actual FTEs delivered by BCIT for non-domestic students. These FTEs not counted towards the Ministry FTE target.
Graduate	Student who earned a credential upon completion of a program.
Apprentice Completer	Apprentice student enrolled in the last level of apprenticeship program.
Graduate Outcomes – PSI Average	Post-secondary institute (PSI) average is the average of all institutions (excluding BCIT) who participated in the designated B.C. Stats survey. The PSI Average for Degree does not include the research intensive universities (UBC, UBC-O, UNBC, UVIC and SFU).
DACSO	Student outcomes survey conducted by B.C. Stats of BCIT graduates who completed a Diploma or Certificate credential.
APPSO	Student outcomes survey conducted by B.C. Stats of BCIT last level Apprenticeship completers.
BGS	Student outcomes survey conducted by B.C. Stats of BCIT graduates who completed a degree (bachelor) level credential.
Employee (Headcounts)	<p>Employees on staff April 1st each year, hired for a regular, on-going position on a part-time or full-time basis. Includes all employees on paid or unpaid leaves. Employees on long term disability or temporarily replacing regular staff on leave or absences are not included.</p> <p>The headcounts reported cannot be compared with Employee Budgeted Full-Time Equivalence (FTE) or budgeted positions. The headcounts are based on a snapshot and may not reflect BCIT's total employee headcount for the reporting year.</p>
Part-time Instructors (Headcounts)	<p>Headcounts represent an average number of Part-Time Studies instructors being paid every pay period.</p> <p>The headcounts reported cannot be compared with Employee Budgeted Full-Time Equivalence (FTE). The headcounts are based on a snapshot and may not reflect BCIT's total employee headcount for the reporting year.</p>
Fiscal Year	Reporting period of April 1 to March 31 of a given year.
