

Attraction Association of Canada and proud supporter of many local charites.





# **Businesses venture forth** at **BCIT**

#### RENAMED CENTRE TO OFFER MORE PROGRAMS FOR SMALL AND MEDIUM COMPANIES



FOR CLOSE TO TWO DECADES, the Venture Development Centre at BCIT has been starting entrepreneurs off on the right foot. Now the centre, newly renamed in memory of its former director, is helping them take the next step.

The Peter Thomson Centre for Venture Development, Founding Partner CIBC will soon be adding new initiatives to its flagship Venture and BCIT Employment Skills Training (BEST) programs, both of which have been the springboard for numerous successful businesses throughout the province.

In early 2009, through collaboration with boards of trade and chambers of commerce around the province, the new Virtual Hub will provide web-based seminars. These will be delivered using applications like video- and tele-conferencing, webcams, voiceover Internet protocol, and text chats to communicate with its clients — whatever works in a situation. Some of the

technology is advanced and gives the participants a sense of being in the same room as the presenter.

Initiatives like the Virtual Hub are designed to meet the changing needs of our time-challenged graduates and other entrepreneurs who are running small and medium sized enterprises, says Ken Takeuchi, a business advisor with the centre.

Businesses can sign up for seminars that could be as short as one hour and are based on a range of requested topics. Those leading the seminars might be from the Peter Thomson Centre, BCIT's School of Business, or other experts in their fields. From there, if they need more help, the centre can provide additional resources.



# Forestry gets greener at BCIT

IT'S BEEN SAID THAT CHANGE STARTS when someone sees the next step. And for forestry, BC's most important industry, creating an educational program that looks forward and takes strides towards sustainability has already been a decade in the making. At BCIT, the staff, steering committee, students, and a handful of industry experts worked together to change the future of forestry by developing the Sustainability Resource Management (SRM) program.

"Our forests and other natural resources are becoming more and more valuable with time and in ways that no one could have imagined, even 20 years ago," explains Peter Barss, program head for the Forest Ecosystems department at BCIT. "As these values increase the motivation and need to manage resources, there will be more opportunities for the natural resource technologists that we're training today."

Barss heads up the SRM Program, which was created both as a reaction to industry needs and an assessment of future opportunities.

"In addition to the traditional forestry jobs, our graduates were being hired by oil and gas exploration companies, by developers of hydroelectric projects, by municipalities to help manage natural areas in and adjacent to urban and industrial developments, and so on," notes Barss. "We recognized that the training needed to reflect a much wider application of skills."

The SRM program aims to educate students on the balance between traditional forestry resource sectors and a wide set of sustainable resource management concepts. In the simplest terms, they study the relationship between the social, economic and environmental needs and apply them to an industry and a province where all three of these forces factor heavily. It's about meeting the needs of the present without compromising the ability of future generations to meet

While creating new programs is nothing new for BCIT, designing a viable SRM program meant throwing out the rule book.

"To be successful we had to add features that would attract and retain students, while ensuring that they are job ready," adds Barss. "In the end, we designed a unique program in terms of content and delivery method."

The SRM program is offered on a part-time basis to meet the needs of students who wanted to study and work at the same time. With the option to exit after one year or continue on in one of two Diploma of Technology options and gain industry accreditation, the program offers an equal mix of academics and hands-on

The first group of graduates from the SRM program will enter the workforce in the summer of 2010.
